Notable for Fiscal Year 2021:

Throughout this fiscal year, Via met the continued COVID-19 pandemic challenge head-on, pivoting in many ways so that the agency continued to be sustainable and meet its mission. Pennsylvania required Via to close on multiple occasions as COVID-19 cases increased. When services were open, the agency had to deal with strict capacity limitations, ensuring all health and safety protocols were implemented, the inability to fill job openings and other COVID-19 challenges.

Via's leadership team worked diligently to find and apply for all federal, state, local and private funding to ensure that the agency remained stable, rebuild and position itself for growth when the pandemic ends. The agency made the decision to refocus its resources on its core mission and made the difficult decision to close its last Thrift store and end its hosting of its two special events, the Via Marathon and All-Star Basketball celebration. It garnered additional support for its core services through strong relationship- and coalition-building and advocacy. Pre-COVID-19, Via was serving 760 people each month. At the beginning of the pandemic, Via was serving only 27 people each month (April 2020). At the beginning of fiscal year 2021, Via was serving 237 people and by the end of the fiscal year Via served 616 people (81% of pre-COVID level).
